

MONTANA NONPROFIT ECONOMIC IMPACT REPORT

Released January 2023

Montana's charitable 501(c)(3) nonprofit organizations employed 10.3% of the state's total workforce and paid \$2.6 billion in total wages in 2021.

In 2021, Montana's charitable nonprofits comprised 3.8% of all establishments, employed 10.3% of all workers, and paid 10.5% of all wages in the state. **2,335 nonprofit establishments employed 49,610 people and paid almost \$2.6 billion in wages.**

Approximately 5.4% of nonprofit establishments were hospitals or health care facilities which employed 22,242 workers over the course of the year making them one of Montana's largest employing industries. Hospitals and healthcare aside, charitable nonprofits employed 27,638 Montanans.


37% of charitable nonprofits operate in rural areas and make up 31% of nonprofit employment.
